Transportation permits shall be required for all oversize loads in accordance with City policy and the California Vehicle Code. The City is empowered, but not required, to permit such loads on City roadways and to apply reasonable restrictions.

Permits are \$16.00 and shall be issued on a per-trip basis (no annual permits). The applicant is expected to submit payment to the City immediately upon receipt of a Permit. Credit card payments are not currently accepted. Check or money orders should be made payable to "City of Turlock." Payment may be submitted in-person at the City of Turlock's Finance Division during normal business hours or by sending via mail to: City of Turlock, Finance Division, 156 S. Broadway, Ste. 114, Turlock, CA, 95380. All payments shall indicate the permit number(s) to which the payment applies in the memo line. A single payment may be made for multiple permits. Failure to submit payment for a permit may result in placement into a "pre-payment required" status, where future permits will not be issued until past due permits are paid in full.
